**APPLICATION FOR FINANCIAL ASSISTANCE
TERMS & CONDITIONS**

- 1. Complete Application.** I certify that all the information contained in this application is true and complete to the best of my knowledge. I hereby authorize the U.S. Green Building Council, Inc. and its officers, directors, employees, and agents (collectively, the “USGBC”) to review this application and to determine our eligibility for financial assistance. I agree to cooperate promptly and fully in any review of this application. I agree to submit any additional information requested. I agree that USGBC may contact persons listed on this application in order to verify the information provided.
- 2. Financial Assistance Provisions.** If USGBC approves financial assistance, financial assistance is approved solely for me, the applicant, and will be paid directly by the USGBC to vendors providing transportation, accommodation, and food and beverages at the Conference as identified and approved by the USGBC. I understand and agree that financial assistance will not be paid to me directly. USGBC is not responsible for payment of any amount other than the specific amount of financial assistance approved by the USGBC based on my application.
- 3. Compliance with USGBC Rules.** I have read and agree to abide by the USGBC’s policies and procedures, including but not limited to those listed below. I will read and keep up-to-date with these rules.
- 4. Consequences of Noncompliance.** In the event of a violation of a USGBC rule or of these Terms & Conditions, I agree that USGBC may take one or more of the following actions:

 - a. refuse to approve financial assistance, waiver of registration fees, and/or workshop fees and continuing maintenance program credits;
 - b. withhold approved amounts;
 - c. demand a refund;
 - d. suspend or terminate its approval of financial assistance;
 - e. declare the applicant ineligible for further financial assistance; and
 - f. take other remedies that may be legally available.
- 5. Indemnity**

 - a. I agree to indemnify the USGBC for any third-party claims arising out of any action taken pursuant to the policies and procedures of USGBC with regard to this application and financial assistance (if any). The provisions of this indemnity do not extend to claims based on the gross negligence, willful misconduct, or intentional misconduct of USGBC.
 - b. I acknowledge that the submission of this application does not in any way bind USGBC to provide assistance, and that the extent and amount of any assistance provided shall be at the sole discretion of USGBC.
- 6. Sole Agreement.** This document contains the entire agreement between me and USGBC concerning financial assistance from the USGBC. This document supersedes all prior and contemporaneous oral and written understandings. No amendment of these Terms & Conditions will be valid unless in writing and signed by me and USGBC.
